GOOD HOPE RESORT

DOGS ARE STRICTLY ON APPLICATION – As you can see by the sign at the front gate, dogs are only on application. Dogs are prohibited to Day Visitor guests. At certain times of the year we people staying the night may apply and will be charged \$15 per visit. ONLY caravan site holders and licenced house site owners may have one or two all year round without charge. To gain approval you will need to meet a certain criteria:

- 1. You will need to produce a current vaccination certificate minimum 24 hours prior to arrival.
- 2. Agree to the park rules **never** off the lead especially next to the water, don't ever leave them alone (they cry you don't hear them we do), control barking, any complaints you must be prepared to take them home and clean up after them.
- 3. Only friendly / approachable dogs are accepted. You will need to bring your dog in so we can meet it. Dogs of dangerous breeds will be refused entry.
- 4. Each Dog must wear a Good Hope Resort issued dog tag whilst in the park; all dogs without our tags will be made to take their dog home immediately.

FIRES -

A fire ban is in-force here at Good Hope Resort and on **ALL** the foreshores of Lake Burrinjuck, you can however have a fire in a fire-bucket or fire-drum **but it must be off the ground**. When we have a Total Fire Ban will then signs will be posted at the main entrance, this means **NO fires are allowed at all**. Should you have any questions in relation to fires please direct them to the Park Owners prior to lighting. Fire Works are prohibited unless prior arrangements are made with the Park Owner and Local Authorities.

NOISE CURFEW -

Please note that Good Hope Resort is a family park and we respect that families have young children, therefore we have a 10pm NOISE CURFEW (including music, driving of vehicles and loud voices), the 10pm CURFEW applies mid-week and on weekends. CHILDREN under the age of 17 must be accompanied by an Adult over the age of 21 years & between the hours of 10pm and 7am

UNSAFE DRIVING:

WE HAVE A STRICT ZERO TOLLERANCE TO UNSAFE DRIVING HERE AT GOOD HOPE RESORT:

including but not limited to ANYONE DOING DONUTS, INTOXICATED DRIVERS, UNDER-AGED DRIVERS, ETC. If caught you AND anyone else in the vehicle will be made to leave the park IMMEDIATELY without warning.

USE OF MOTORBIKES, QUADS & UNREGISTERED VEHICALS –

HOURS FOR RIDING: 10.00am TO 5.00pm ONLY! (i.e. NO RIDING AT NIGHT)

NOTE: No riding in the months of DECEMBER AND JANUARY or when the water level is above 70% For your safety and comfort of others in the Park Motor bikes, Trail Bikes, Unregistered Vehicles and Unlicensed Drivers are not permitted on Good Hope Resort roads, ride only on the river-flat area (away from other people cars, the boat ramp & boats). This is considered and adventurous activity and YOU ARE RESPONSIBLE FOR YOUR CHILDREN'S ACTIONS (AND THAT OF YOUR OWN) so we encourage you to watch them at all times and make sure they abide by the rules.

a) Good Hope Resort being a public place, the same road rules apply as on a city street and Police can and do enforce them.

- b) Any one riding or driving any vehicle does so at their own risk. Should you feel it unsafe to ride don't let them! Encourage them to stay at least 100mts away from any campers and vehicles.
- c) Operators of motorcycles and quad bikes shall **take the most direct route to the river flat area** or area below the high water level, **at a speed of 5KPH**. If the river flat area is covered in water then there is no other place to ride.
- d) Prior to riding the area should be thoroughly investigated for stones, posts, fences, etc. It is a dangerous sport & be aware of where you're riding.
- e) If you are riding do not go within 100 mts of sheep or any stock.
- f) If you are not sure where to ride walk to Reception or phone on (02) 62271234 and ask. If you can't accept these rules then leave your bike at home.

The park rules are modified based on experience and the above are also based on SAFETY therefore we do except your cooperation.
